**ORDER:**

In partial modification of the orders issued in the G.O. seventh read above, Government hereby revise the remuneration payable to the Government Pleaders of the High Court for the State of Telangana, appearing in contempt cases filed against Public Officials, from Rs.4,000/- (Rupees four thousand only) to Rs.10,000/- (Rupees ten thousand only) per case, in addition to the monthly consolidated honorarium, as recommended by the learned Advocate General for the State of Telangana in the letter sixth read above, with immediate effect.

2. The Government Pleaders should strictly adhere to the instructions issued in the Memos third and fifth read above.
