In the G.O. 2<sup>nd</sup> read above, Government have constituted the Advisory Board on Preventive Detentions and notified the same in the Telangana Gazette Part1, Extra - Ordinary No.235, Dated: 11.11.2021 in place of the Advisory Board Constituted in the G.O. 1<sup>st</sup> read above. In G.O. 3<sup>rd</sup> read above, Government have constituted the Advisory Board on Preventive Detentions and notified the same in the Telangana Gazette Part1, Extra - Ordinary No.22, Dated: 29.01.2024, in place of the Advisory Board Constituted in the G.O. 2<sup>nd</sup> read above. The term of the Chairman and members of the Advisory Board is coming to an end by 30<sup>th</sup> January, 2026.

2. After careful consideration, the Government hereby extended the term of the Advisory Board on Preventive Detentions constituted vide G.O.3<sup>rd</sup> above under the relevant provisions of the various Preventive Detention Acts including Central Acts in force, for a further period of two (2) years w.e.f.31.01.2026, with the following:-
