ORDER:

In the circumstances reported by the Chief Commissioner of Land Administration, Telangana, Hyderabad vide reference read above, Government after careful consideration of the matter, in the interest of administration, decided to effect promotions to the cadre of Special Grade Deputy Collector from the eligible candidates in the cadre of Deputy Collectors on purely ad-hoc basis in relaxation of Rules subject to the outcome of court cases.

**2.** Accordingly, Government, under Rule 10 (a) of the Telangana State and Subordinate Service Rules, 1996, hereby order for the promotion of certain Deputy Collectors, in relaxation of Rules (5) and (6) of Telangana State and Subordinate Service Rules, 1996 and the orders issued in G.O.Ms.No.549, Revenue (Ser.I) Department, dt:8.8.2001, as Special Grade Deputy Collectors, in the category-I of Telangana Civil Service (Executive Branch) Rules, 1992 in the scale of pay of Rs. 76830-151000 (RPS, 2020) purely on ad-hoc basis.

**3.** The following promotions as Special Grade Deputy Collectors are notified.

**4.** On promotion as Special Grade Deputy Collectors, they are retained in their places of working, until further orders.

**5.** The promotions ordered in Para (3) above on ad-hoc basis are subject to the following conditions:

- i. Subject to the outcome of all the court cases which are sub-judice at present.
- ii. Subject to review of the panels at any time.
- iii. The appointment is subject to outcome of the O.As / W.Ps, SLPs pending before the APAT / High Court or Supreme Court.
- iv. The appointment is purely temporary under emergency provisions and does not confer any right of any kind on the individual who is liable to be reverted at any time without prior notice and without assigning any reasons thereof and the excess amount drawn, if any, in this category will be recovered.
- v. The Officer shall not be regarded as a Probationer or be entitled by reason only of such appointment to any preferential claim for future appointment to such service, class or category.
- vi. The Officer appointed, whether or not he/she possesses the qualification prescribed for the service, class or category to which he/she is appointed, be replaced as soon as possible by the other individual, who is entitled to the appointment under the rules.
- vii. The appointment by promotion is also subject to joining of the Officer in the promoted post within the stipulated time of (15) fifteen days from the date of receipt of the order of appointment and promotion as specified in Rule 11(b) of Telangana State & Subordinate Service Rules, 1996, failing which he/she would forfeit the right of promotion to the cadre of Special Grade Deputy Collector.

6. The Chief Commissioner of Land Administration, Telangana, Hyderabad / District Collectors / HODs concerned are requested to intimate the relief and joining of the officer to the Government.
